2020 Annual Report Pastor Jim Wilson, Interim Associate Pastor

I was blessed to join Pastor John and the Prince of Peace ministry staff in mid-March as part-time interim associate pastor. A call committee had formed, but some ministry needs existed beyond what the senior pastor and staff had capacity. I was honored to be asked. The plan was to be formally introduced at all four weekend worships on Sunday, March 22. That, however, was the first Sunday we disbanded in-person worship for the safety of our community and congregation. It has been uncharted territory since that time for all of us, and certainly slowed call processes across the whole church.

Early on I was asked (at a Senior Ministry Zoom) about my job description. I shared that it included some preaching and teaching, some visitation and "really any other way Pastor John thinks I could be useful." There were a few chuckles, but having been a senior pastor for many years, and familiar with those demands, and having known Pastor John as friend and colleague for many of those years, I appreciated then, and do now, the authentic description. Flexibility has been so important, and I have been so impressed with the maturity of Prince of Peace's staff and congregational leadership. We are blessed.

- Our Church Council has navigated these challenging times with skill and faith, incorporating staff
 and pastoral leadership. We can all be thankful for their discernment throughout a trying year. It
 has served this church well as they carefully monitored congregational finances, approved facility
 repairs and kept an eye on financial trends. This church is blessed with significant resources and
 committed leadership.
- I have missed in person worship as I'm sure have you. I give thanks for the high-quality on-line worship that Pastor John, Jeremy Bankson and the 'pandemic choir' have provided during a very difficult time. We all miss being together.
- Our annual stewardship emphasis based on the spiritual disciplines of gratitude and generosity was especially meaningful. We are, indeed, called to be thankful and generous in all circumstances. This community is economically blessed. Thank you to all who are faithfully and generously responding.
- The gifts and faithfulness of your Global Mission Team were manifested in your significant response to the need to cancel Closet Cause. You responded generously and the love of Christ is being shared literally around the world through this year's direct appeal effort. I have witnessed the grateful responses of our global partners in what must feel like a 'pandemic miracle' to them too.
- Both Pastor John and I are saddened by the inability to visit in hospitals and nursing care centers. The Prince of Peace community continues to pray and love those more isolated than others.
- Twelve Days of Christmas devotions were fun to produce and you have shared that they are meaningful. Of course, those were possible because of the efficiency of Jocelyn Alford, the technical and musical gifts of Jeremy Bankson, and the joyful generosity of our musicians.

Thank you for allowing me to serve with you at Prince of Peace Lutheran Church during this unusual year. God is powerfully at work among this community and even now doing a new thing among us. I am grateful to be included.

2020 Annual Report Jeremy Bankson, Director of Music

It will come as no surprise that this is, without question, the most unusual year of my career in music ministry! I am sure anyone reading this can identify with the fact that almost everything in our lives has been affected by the COVID-19 virus which has plagued the world. Despite that, I am glad to share many good things that have happened in the Music Ministry at Prince of Peace.

I am thrilled to share that at the start of 2020, we had more participants in the Music Ministry than ever before in my time at Prince of Peace. One of the early highlights for our community was a concert presented by the Prince of Peace Choir, accompanied by orchestra to share "Song of Stillness" by Andrew Carter along with other music that calls us to calm and stillness. Nobody would have guessed that the March 8th concert would be the last time we would fully gather prior to shutting down.

I want to say a special thank you to the handful of people who despite the challenges and dangers of public gatherings, committed to each other to record music for our worship services. Palm Sunday was presented in an audio recording, and from Easter Sunday onward, I have taken on the task of video production with this small group of singers and a few instrumentalists which continues weekly. We were SO fortunate that we had several family units that included multiple singers in one "bubble" to keep our gatherings small. I am thankful to Pastor John and Pastor Wilson, as well as the entire staff for their aid in this weekly production.

In addition to weekly services, we also produced a special service of healing during the summer, an expanded Christmas Eve Service, a 13-video series for the 12 days of Christmas and a monthly family video for the children of our parish.

We were also able to have a few gatherings of more singers who rehearsed outside and gathered only briefly to record for Reformation, and our Handbell Choir has also had the chance to gather in a socially distant manner to record music broadcasts.

While NONE of these videos can replace the joy of gathering in person, they have become a way for our church to reach out into the world! I regularly get comments from people all around the country who have watched and appreciated our video ministry. These efforts led to one of the most exciting events to happen in 2020 for our community. The church council voted unanimously in December to install a permanent Audio/Visual system that will allow us to record services and events as well as live stream our services when we are gathering in person again. There is SO MUCH that our community has to offer, and the chance to share this ministry in a virtual way is very exciting!

In addition to the installation of a new AV system for broadcast, I'm grateful to Pastor John for his vision of revamping the front of our chancel to accommodate a growing music ministry. He suggested that we could make much better use of the space in front which would then allow for more seating in the sanctuary. While we were both excited to try this for Easter, it will simply have to wait a little longer to appreciate the full opportunity of more seating.

While I GREATLY miss the weekly gatherings to rehearse and prepare for worship, I do believe we have light on the horizon and look forward to the day when we can safely gather in person. I look forward to welcoming so many wonderful souls who constantly share their talents to help us express and share our faith. With our new AV system, I look forward to sharing those days not only with people in person, but with people throughout the world!

I miss the daily interactions of interacting with Bible studies and groups within the building, but am very thankful for all the wonderful and willing volunteers who have helped to keep all the many little things going and keep us connected during this year. Thank you to Ruther Pistner, Amy Brack, Robin and Jessica Cook, Anna Krueger and Kay Crosby who were invaluable in helping with this years' stewardship campaign and its multiple mailings; Diane Andrick who continues the Splash! ministry for families of newly baptized little ones, Kay Crosby who organizes the Layettes ministry, Marge McDonnell and Cathi Galli and Kathryn Nestor who purchase fabric and regularly make blankets for layettes, Wendy Reeves who made our beautiful sanctuary bouquets, Jody Luken who continued to calligraph baptismal certificates, Joyce Harmon who keeps loved ones in our prayers by sending inspiring cards to those housebound. And Marge McDonnell who continues to weekly write and send welcoming cards to all those in our congregation.

Much has been learned this year about how to connect and share fellowship together. The challenges of the past year have stretched our faith, as well as stretched our ability to 'think outside the box' to continue to support and meet each other's needs. It has forced a reckoning of looking within to simplify and to focus on the basic fundamental teachings and work of the church as we care for our community and friends.

I hope to learn and rebuild from the many lessons of 2020 and look forward to the blessings of the new year.

2020 Annual Report Jess Lweno, Youth Director

What an interesting year it has been! While the pandemic has certainly put many things on hold, and we are again worshipping and continuing our Christian Education online, I wanted to take a look at what we have done over this past year.

Our High School Sunday School, now called the "PoP HS Breakfast Club" started up again this fall with socially distanced gatherings at Coffman Park. As the weather turned colder, we continued to meet via Zoom on the 1st and 3rd Sundays of the month. We spent Fall sessions looking at topics from the "Book of Faith" series by the ELCA and making connections in our own lives to those of people in the Bible. One of the topics was "Dwelling in Faithfulness" and we spent time reading about Job and his faithfulness to God through his many struggles. Breakfast Club is a great time of discussion, Bible study, and Fellowship. I encourage all of our high school students to join us.

It has been very difficult for our 2020 Confirmands and their families to have had their Confirmation cancelled. I ask that you all please continue to pray for these young people as we plan for a special and safe Confirmation service for them.

This fall, we started our Confirmation Community groups. These small groups of 8-10 Confirmation students that are led by one of 7 adult leaders throughout the week. We are very happy with the first session and are beginning another session, leading up to Lent. The relationships that are being built in these communities are very special as typical Confirmation classes can be anywhere from 20-60 students.

To wrap up the year, we had a joint High School and Confirmation Zoom event called "KIVA: A Celebration of Giving". We had 40 youth in attendance along with 7 adult leaders and learned about the KIVA program and broke into small groups to make microloans around the world. In about 10 minutes we were able to loan out nearly \$1000 to 10 different people, 10 different countries on 4 different continents. Our youth really enjoy the KIVA program and are encouraged to make loans as funds are available. Special thank you to Martha Scherpelz and the Global Missions team for making this possible.

What I love about Prince of Peace is that, while many of our families do live in Dublin, we have families from all over Northwest Columbus. This means our students do not attend the same school. While this does bring on challenges, the goal of these communities is to build lasting friendships amongst our youth that will continue, regardless of where they attend school.

In normal circumstances, we would be preparing for the 2021 ELCA Youth Gathering, however due to the pandemic it is rescheduled to summer of 2022. I encourage all current 7-11th graders to consider going on this trip. It is often regarded as a huge milestone in the faith journey of young adults across the country.

While this year has been a challenge for everyone, I believe we have all learned how much our church families mean to us, and how important it is to rise up and try something new. I am hopeful that 2021 brings us back together, sooner than later. And I look forward to continued ministry here at Prince of Peace.

Thank you all for your support in this ministry here at Prince of Peace. I am looking forward to what this year has in store!

Mission Statement: Parish Health Ministry (PHM) encourages health awareness and provides opportunities to share the healing ministry of Christ with others.

Sharing this ministry of Christ has been challenged and adjusted this past year in response to our efforts of promoting safety for ourselves and others. Programs and speakers were cancelled, home and facility visits are temporarily suspended, and the informal "how are you today?" interactions that normally occur at church are on hiatus.

However, our successes this past year include:

- > Participation in the development and oversight of safety measures during the pandemic
- > Continued weekly articles in Peace Signs.
- > Supportive communication with members requesting information on health-related topics for self or family members.
- > Continued the 20+ families receiving the grief support mailings *Journeying Through Grief* organized by Linda Ogden.
- > Supplied hygiene kits for both First English Lutheran Church and students in the summer free lunch program at Dublin Schools.
- > Learned that it's sometimes easier to attend a national conference via Zoom ©
- > Discovered new health ministry networking groups outside of Prince of Peace.
- > Maintain connections with home or facility-bound members.
- > Continue to loan out durable medical equipment.
- > Creation of *PoP Chat* to virtually connect with other PoP members to provide connection in a fun and social format.

Due to the pandemic, the Global Mission Group took an alternate approach to 2020 fund raising in support of our mission partners. Even though we were not able to hold the annual 'Closet Cause' sale in 2020, the group decided to increase our goal for the year in recognition of the critical need for funding our partners.

The group set a goal of \$50,000 for the year. This was at 25% increase over the funds raised in 2019. With the help of an anonymous gift of \$25,000 and a strong response from the congregation, we were able to raise more than our goal for the year. The effort was supported by a wonderful video, produced by Becca Scherpelz, that highlighted our partners, the work they support and the regions of the world in which they work.

We also added an additional partner to our list of supported ministries in 2020. With the expanded funding, we were now able to support a total of 11 mission partners.

Global Mission is an expanding ministry at Prince of Peace. The group currently has 15 members and new people are always welcome. Meetings are held the first Saturday of each month at 9:00am. In 2021 Global Mission plans to continue to expand our involvement by supporting additional relief organizations and increasing the funds that are raised. We are currently considering two additional partners for support in 2021.

While we hope to have a more traditional fund-raising effort in 2021, it is likely that we will need to approach the new year with a combination of methods in order to increase our funding for the groups world-wide that count on our support.

During 2020 the Property Committee continued to meet safely (usually outside with masks) to keep the grounds and buildings of Prince of Peace in good working order.

Completed projects for 2020 included:

- 1. Total roof replacement Paid for by Insurance.
- 2. Gutter replacement approximately 50% of all gutters.
- 3. Planted four arborvitae shrubs along Hahn Property, as part of an ongoing project to re-establish a buffer as required by the City of Dublin.
- 4. November Property Clean-Up and Raking.
- 5. Re-carpeting worn carpets in the Preschool.
- 6. Purchase and assembly of tables for the patio (thanks to the Alford family for assembly!).
- 7. Sanctuary finishes painting new risers and installing guard rails, additional storage for sacristy, permanent and movable risers for font pulpit and altar, screening of wires on back wall.

Anticipated Projects for 2021 will include:

- 1. Convert parking lot lights to energy efficient LED bulbs.
- 2. Extend WIFI and network capability to Sanctuary for security and video upgrade.
- 3. Updated camera system in sanctuary with capabilities for simultaneous recording and livestreaming.
- 4. Consolidation of all security cameras into one unified, updated system.
- 5. Additional carpet upgrades in Preschool.
- 6. Explore purchase of an upgraded dishwasher in the kitchen.

Chris Joos, Church Treasurer December 31, 2020 Financial Results and 2021 Budget

Who would have known with all the turmoil in 2020 it actually turned out to be a successful financial year for Prince of Peace? I would like to give special thanks to all of you for your continued generosity and stewardship even when we cannot worship together. Below are some of the highlights for the year:

Monthly Cash Flow - 2020

For 2020, we ended with a total cash gain of approximately \$97,500. Key points regarding 2020 were:

- While total operating income was less than budget by \$110,600, operating expenses was less than budget by \$153,000, thus generating a \$42,400 gain from operations.
- The largest saving in expense came from Salaries & Benefits (\$71,800) as we did not fill the associate pastor position and \$39,900 saving as Thrivent allowed us to defer six months of mortgage payments.
- Total designated income was more than budget by \$58,300, while designated expenses was more than budget by \$3,200, thus producing a 55,100 gain from designated funds.
- Total Building Fund was \$106,700 which allowed us to pay \$39,900 of mortgage payments and \$66,800 of capital improvements. Please note church equipment & repairs exceeded budget by \$38,750 to pay for additional repairs and down payment for new video equipment.

Designated Funds and other Financial Information - 2020

- Total cash balance ended at \$277,700. This amount exceeds all other designated funds by approximately \$87,000.
- Our mortgage is now at approximately \$290,000. We decided not to pay extra mortgage payments in 2020 to allow for more flexibility in cash reserves in 2021.
- Deferred Maintenance Fund was increased to \$45,000 to account for projected new capital expenditures.

<u>Summary Financial Report and Budget – 2021</u>. Below are some highlights:

- 2021 is a difficult year to budget due to guessing when Prince of Peace will be fully open. For the sake of our monthly budgets, we choose budget full operations staring September 2021
- Total budgeted income of \$1,108,175 is budgeted to be 1.0% higher than prior year actual.
- Total operating expenses are budgeted to increase 4.6% over prior year with a projected operating income of \$4,450. Some highlights are:
 - o Salaries and benefits are projected to increase by 5.3% due to budgeting again one full-time associate pastor for second half of 2021.
 - Property expenses are budgeted to decrease 22% due to the deferred maintenance fund increase and since 2020 capital expense included extra one-time projects.
 - Designated funds are expected pay out \$29,2450 more than it will take in. The largest variance is with the preschool with a projected loss of approximately (\$21,200) due to smaller class sizes and \$0 budgeted for additional PPE loan and other grants that were received in 2020.
- As a result, projected cash income from operations and designated funds is expected to be a loss of \$25K.

Designated Funds and other Financial Information - Budget 2021

Below are some highlights:

- Cash is budgeted to decrease to \$252,700. This allows us to cover all designated funds by \$91,400.
- Total mortgage is projected to be \$216,950 at the end of 2021 and estimated to be totally paid off November 2024.
